## **DUBAI AUTODROME ROLL RACING TERMS AND CONDITIONS OF PARTICIPATION OR ATTENDANCE**

### **GENERAL**

1. These Terms and Conditions apply to all bookings or events attended by any person of any age.
2. By booking with the Dubai Autodrome, you agree on behalf of yourself and if not yourself, the driver to be bound by our terms in their entirety.
3. Dubai Autodrome accepts no booking by you unless or until they have received payment in full.
4. These terms and conditions replace any earlier terms and conditions related to Roll Racing. No variation to these Terms and Conditions shall be binding unless agreed in writing by Dubai Autodrome and signed by an authorized representative.
5. Last run for cars will start at **11.30pm**; any car completing a run after this time will be guided back to the paddock and cannot return to the holding area.

### **PRICING & PAYMENT**

1. The price of a booking will be the price stated on the booking portal and any other advertised material.
2. The price stated is per car per session. Should you wish to book additional services such as additional drivers, passengers, helmets, they will be charged at the published rate.
3. Any subsequent variation in the Price agreed by the Dubai Autodrome will only be valid if confirmed in writing to you.
4. Payment of the stipulated price will allow you to reserve a place (if one is available) on the Roll Racing session operated by the Dubai Autodrome.
5. Dubai Autodrome is under no obligation to run any Roll Racing or reserve any date selected by you unless the price has been paid in full. Until such time, Dubai Autodrome may offer any date selected by you to another party.
6. Payment may be made by the booking link, bank transfer to Dubai Autodrome's bank account, or by credit card or debit card on site prior to the start of the Roll Racing sessions. Price variation as published on the website for Online vs Assisted Bookings/On-site will apply accordingly.

### **CANCELLATION**

If you cancel a Roll Racing booking for any reason within:

1. 28 days or more before the scheduled date, Dubai Autodrome will refund 80% of the fee paid.
2. 21 days or more before the scheduled date, Dubai Autodrome will refund 50% of the fee paid.
3. 14 days or more before the scheduled date, Dubai Autodrome will refund 30% of the fee paid.
4. 7 days or more before the scheduled date, Dubai Autodrome will refund 20% of the fee paid.

5. 6 days or less, no refund will be provided.

Once a booking has been confirmed, any amendments to the date or time may only be made up to 3 days before the booked date and will be subject to an administration fee of 250 AED, subject to availability.

## **FORCE MAJEURE AND REFUNDS**

1. Dubai Autodrome reserves the right to cancel a Roll Racing session due to any conditions that may affect your safety.
2. In the extremely rare occasion, the event needs to be cancelled for operational reasons, Dubai Autodrome will notify you in advance. Dubai Autodrome will refund you in full, the fee paid.
3. Refunds will be processed within 45 working days via credit/debit card reversal, or bank transfer, depending on mode of payment that was completed for the booking.
4. It is the responsibility of the driver to ensure they meet the minimum requirements for the Roll Racing sessions. Should the driver arrive for the Roll Racing session and be found to not conform to the minimum requirements, it is then at the discretion of Dubai Autodrome to not allow the driver to participate. No refund will be provided in this case.



## **BOOKING CONDITIONS**

1. Driver must be in possession of a valid driving license from UAE. Driving Licenses issued in other countries are accepted provided that the relevant license details are written in English.
2. Open wheel race cars are not allowed.
3. No extreme modifications are made on the vehicle that compromises the safety of the overall vehicle (removing brake pads, adjusting wheels to a position deemed unsafe) etc.
4. You agree on behalf of yourself and the Driver to observe all circuit/track rules and regulations and all instructions given by Dubai Autodrome including the instructors.
5. You agree on behalf of yourself and the Driver to observe and comply with any advice, instruction, request or decision made by Dubai Autodrome whether on the grounds of the safety of the Driver or any other person or for any other reason at all.
6. You agree on behalf of yourself and the Driver that Dubai Autodrome's opinion on all matters regarding safety will be final.
7. You agree on behalf of yourself and the Driver that any Driver acting in a manner which in our opinion is dangerous or may interfere with or disrupt the Roll Racing session will at our sole discretion and without further liability to us immediately have their session terminated without refund.
8. You agree on behalf of yourself and the Driver that Dubai Autodrome reserves the right to not allow you entry to the circuit or facilities should you not meet the eligibility criteria for Vehicles or Participants mentioned in the Terms and Conditions document.
9. You agree on behalf of yourself and the Driver that the Driver meets our minimum requirements for the Roll Racing session.
10. The Driver must not have consumed any alcohol prior to the Roll Racing session, and Dubai Autodrome reserves the right at the time to prevent a Driver from driving who in our opinion may have consumed alcohol beforehand.
11. No Driver will be allowed to take part in these Roll Racing session unless they have attended the full safety briefing preceding testing.

12. That where required, all drivers must wear a crash helmet and suitable sports shoes. Sandals are not acceptable.
13. You agree on behalf of yourself and the Driver that any damages caused by you or the Driver whilst on track or at the venue, will be paid for in full.

## **SCRUTINEERING**

1. Both driver and passenger must step out of the car during scrutineering
2. All cars must pass technical inspection before participation
3. Cars failing inspection will not be allowed to participate
4. Chief Scrutineer's decision is final

## **LIABILITY**

1. It is a condition of this Agreement that in order for a Driver to take part in Roll Racing, the Driver must be in a fit medical condition to participate in it and must sign the disclaimer of liability agreement prior to its commencement.
2. Any Driver failing to sign the disclaimer of liability agreement will not be permitted to take part in any Roll Racing sessions.
3. You are liable for ensuring all Drivers are sufficiently capable of understanding instructions given to them in the English Language on safety or whilst driving and Dubai Autodrome will not be liable in any way for any consequences arising from your failure to do so.
4. You are liable for the safety of any family or friends attending the Roll Racing. Any provisions in these Terms and Conditions applying to the driver apply equally to such individuals.
5. Pets or animals are forbidden anywhere on the circuit (except Guide Dogs).
6. Dubai Autodrome will not be liable for any event or occurrence outside our control which results in cancellation or modification of any Roll Racing session that is booked by you or advertised by Dubai Autodrome.
7. Dubai Autodrome has Public Liability insurance cover up to a limit for any one event.
8. You are liable for any damages caused to any part of the venue during your Roll Racing session.

## **DATA PROTECTION**

You (and the Driver) will be asked to provide personal information (which may include full name, date of birth and address) in connection with your purchase of and the Driver's participation in the Roll Racing session. Dubai Autodrome reserves the right to use and process any personal information provided by you or the Driver for the purposes of facilitating your, or the Driver's, participation in the Roll Racing session. You will be asked to provide your email address, and the email address of the Driver. Dubai Autodrome may choose to send out information via email to inform you about future Roll Racing sessions.

## **GOVERNING LAW AND JURISDICTION**

These Terms and Conditions are governed by the laws of the United Arab Emirates. Any disputes arising from these Terms and Conditions shall be subject to the exclusive jurisdiction of the courts of Dubai.

## **SEVERABILITY**

If any provision of these terms and conditions is found to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.

## **ENTIRE AGREEMENT**

These terms and conditions constitute the entire agreement between you and Dubai Autodrome and supersede all prior agreements, understandings, or representations.
